2025 marks the 80th anniversary of the Allied victory and the end of World War II in Europe, or V-E Day. Nebraska Governor Jim Pillen has made it his goal this year to ensure those living WWII veterans in Nebraska are honored for their service. In doing this, each WWII veteran has been receiving a recognition medal and a certificate to commemorate their service. It is estimated that Nebraska has approximately 250 living WWII veterans. Through ceremonies at the veteran's house, Nebraska Veterans Homes, local care centers, and at the State Capitol, many of these veterans have already been presented with their medal.

American Legion Commander Boyd Yochum and VFW Commander Kenneth Yount asked Governor Pillen if they would be able to help in any way, and the Governor took them up on that offer. Yochum and Yount attended ceremonies in Burwell, Broken Bow, and a few others and were able to present medals on the Governor's behalf. Yochum said, "It is great to be able to work together with the VFW Commander Ken. We get along really well and its nice to present the medals to those veterans together."

If you know of a living WWII veteran, please sign them up! More information, the eligibility requirements, and the application for the World War II Recognition Program can be found on the Nebraska Department of Veterans Affairs website at veterans.nebraska.gov/world-war-ii-recognitionprogram or you can contact them directly at 402-471-2458. There is also a Hometown Heroes certificate for any civilian who helped out during the WWII war effort back home. That information and application can also be found on that page.



June 1938 (87 years ago)

- Kurt D. Meyer of <u>SEWARD</u> Post 33 has a record for regular attendance at post meetings that his comrades believe cannot be equaled anywhere in the U.S. or anywhere else. He has not missed a regular monthly meeting of his post in the past 10 years.
- <u>DUBOIS</u> Post 39 has the distinction of being the first Nebraska post to send in a check for its 1939 quota. The post this week forwarded a check to Department headquarters for 15 members for 1939, thus already "over the top" for next year.
- William A. **DAFOE** of **TECUMSEH** was elected Cornhusker Boys State Governor in a spirited election held on June 13 at the Nebraska ag college in Lincoln. Dafoe, "Nationalist" party candidate defeated Robert Schwartz, "Federalist" party candidate, of Broken Bow by a vote of 157 to 91
- Grand Island Post 53 will sponsor the first statewide <u>ARCHERY</u> tournament July 11 and 12. Plans are to have a big shoot and to bring together all groups that have helped revive this ancient sport.
- Hard hit by drought that almost paralyzed agricultural activities in recent years, members of <u>CARLETON</u> Post 329 felt it was impossible to erect a new building. So they obtained two unused box cars from Union Pacific and spent many hours tearing down, rebuilding and fastening their new post home to a permanent foundation. Converting the two box cars into a new post home is paying dividends in the form of increased support of the Legion program in that community.
- A big <u>JUBILEE</u> was staged at <u>HASTINGS</u> on June 10 under auspices of the Legion Post 11. The event was to help raise money to finance the trip of the Hastings DRUM and BUGLE Corps to the National Convention in Los Angeles in September.
- The **FRAZIER** Trophy, presented by Past Department Commander C.C. Frazier of Aurora, goes each year to the post carrying on the most work for boys, such as Boys Scout work, junior baseball or other activities making better boys. **COZAD** Post has won this trophy the past three years.

Maynard Jensen Memorial Scholarship



The Nebraska American Legion selected 8 recipients of the Maynard Jensen Scholarship. The Maynard Jensen scholarship began in 1989 as "The American Legion Scholarship" and it was renamed in 1992 in memory of Past Department Commander Maynard Jensen of Aurora.

Jensen was a World War II Navy Veteran who served in the invasion of Normandy and then in Southern France. He served as the Nebraska American Legion Department Commander from 1971-72. Jensen also served on numerous Department Committees within The American Legion.

For the 37th consecutive year, the Nebraska American Legion has done its part in helping Nebraska students with scholarship money. The recipients of \$500.00 scholarships Bree Geschke of Seward, Hannah Beel of Johnstown, Emersyn Shanahan of Cedar Bluffs, Keila Dubas of Fullerton, Brookly Richardson of Central City, Liberty Johnson of Milligan, Jacob Bauman of Lincoln, and Lane Conway of Campbell.

When Saigon fell 50 years ago, what happened to American Prisoners who had apparently been held back after the POW exchange in 1973?

On March 25, 1971, PFC Manuel R Puentes was a rifleman with B Troop, 1st Squadron, 1st Cavalry Regiment, 23d Infantry Division (Americal), and member of a 12-man combat patrol operating in northwest Quang Tri Province, South Vietnam, a few miles south of the demilitarized zone (DMZ).

During the patrol, the team was ambushed by enemy forces. It was reported that PFC Puentes was the first to be hit. Puentes was seen wounded, moving under his own power seeking cover. The radio operator reported rapidly deteriorating conditions in which the patrol found itself. The patrol was forced to withdraw. Puentes was left behind. When soldiers were debriefed, they told investigators that "Puentes was not hurt bad" and that his condition was fair, he was trying to take cover behind rocks.

A reaction force made several attempts to reenter the battle site, but well entrenched communist forces blocked each attempt. When American personnel were finally able to enter the ambush site, they found no trace of the missing rifleman. Likewise, they found no sign of freshly dug graves. At the time the search effort was terminated, Manuel Puentes was listed as, "Died while missing in action (MIA), Body not recovered."

Since the war ended in Southeast Asia, thousands of refugee reports have been received indicating that many Americans were still alive in captivity. Men like Manuel (Manny) Puentes gave all they had for the cause of freedom. Can we afford to turn our backs on these MIAs?

Recently, Manny's brother Jose and nephew Diego traveled to Vietnam, trying to get more information about what happened to Puentes. During their trip to get answers, Jose and Diego saw where the war was fought, met former warriors, shook hands and saluted each other. They were able to get close to where Manny was last seen. There was a small makeshift memorial, and Jose spent a minute talking to his brother, and talking about family members. They think if Manny is still alive, he may be hiding, in captivity, or leading a different life. We don't know.

In early 1975, after all American POWs were supposed to have returned home, communist deserters reported that Americans were still being held.

In 1991, during closed door Senate Select Committee on POW/MIAs, there were some records and information that the Committee could not get. WHY?

All records of American POW/MIAs since World War II are classified. Task Force Omega has respectfully asked our President to do what no president has done since WW I, and that is to sign an executive order declassifying all documents (without redaction) in government agencies that have any information on POW/MIAs that never returned from our wars, police actions, or where our military was operating in foreign countries.

Remaining families and the American people deserve to know what happened to our brave Soldiers, Sailors, Airmen and Marines. No one family should have to navigate classified files and not be able to know what happend to their service member who never returned.

Understanding Dependency and Indemnity Compensation (DIC): A Lifeline for Survivors of Veterans

Dependency and Indemnity Compensation (DIC) is a tax-free monthly benefit provided by the U.S. Department of Veterans Affairs (VA) to eligible survivors of service members who died in the line of duty, or veterans whose death resulted from service-connected injuries or illnesses. This vital benefit aims to support surviving spouses, children, and even parents as they navigate the loss of their loved one and the financial challenges that may follow.

Who Is Eligible for DIC?

Surviving spouses may be eligible for DIC if they lived with the veteran continuously until their death (or were separated through no fault of their own) and meet one of the following conditions: married the veteran within 15 years of their service-connected illness or injury, were married for at least one year, or had a child with the veteran. Spouses who remarry may still be eligible if the remarriage occurred at age 57 or older after December 16, 2003, or at age 55 or older after January 5, 2021.

Dependent children can qualify for DIC if they are unmarried, not included in the surviving spouse's compensation, and under 18 or under 23 if enrolled in school. Adopted children may also qualify under the same conditions.

Parents of deceased service members or veterans are also eligible, provided they are biological, adoptive, or foster parents and have incomes below a specified threshold. The foster relationship must have existed before the veteran's final active-duty enlistment.

What Evidence Is Required?

To receive DIC, claimants must submit evidence proving the service member died in the line of duty or the veteran's death was caused by a service-connected condition. Even a 0% service-connected rated condition may qualify one to receive DIC benefits. If the veteran's death wasn't directly caused by a service-connected illness; however, was rated as totally disabled for a specified period prior to death (100% service-connected disability rating for 10 continuous years before their death or rated 100% disabled for at least 5 continuous years from the date of discharge from active duty), survivors may still qualify.

What's New in DIC Claims Processing?

Beginning in May 2025, the new "White-Glove" Survivor Outreach Team—based at the Philadelphia VA Regional Benefit Office, have been specially trained to work toward favorable outcomes for DIC claims. The VA has introduced further automation of DIC claims. This automation role has increased to over 1,000 DIC-related claims processed daily.

How to Apply for DIC Benefits

The first step in applying for DIC is connecting with an accredited Veteran Service Officer (VSO). VSOs are trained to guide applicants through the process, including completing the VA Form 21P-534EZ, which covers applications for DIC, survivor pension, and accrued benefits. Survivors can find local service officers by calling (402) 471-2458 or visiting veterans.nebraska. gov/cvso.

For those grappling with the loss of a loved one who served, DIC represents both recognition and support. These benefits ensure that the sacrifices of veterans and their families do not go unacknowledged.

Edgar J. Boschult Memorial Scholarship



The Nebraska American Legion has selected five recipients of the 2025 Edgar J. Boschult Memorial Scholarship. The Edgar J. Boschult Memorial Scholarship is awarded to full-time students in the University of Nebraska system that are enrolled in military science courses or to honorably discharged veterans attending the University of Nebraska full-time.

The Edgar J. Boschult Scholarship was created in 1947 in memory of Edgar J. Boschult. Boschult was a veteran of World War I and Past Department Commander of the Nebraska American Legion. Boschult returned to serve his country in World War

II and was killed in action on November 8, 1944.

Membership Minute Steve Bartos, Chairman

As the department convention approaches, it's a good time to take a fresh look at membership. While we all know that the 2025 membership campaign extends through the end of December, we also know that --- realistically ---- we're probably not going to pick up a significant number of additional memberships. Keep trying, though. Let's at least crack the 90% mark.

A year ago, we were looking at some issues that were going to impact membership numbers for a few years into the future. A \$5 national dues increase was going into effect on July 1, and a likely \$5 department dues increase was also being contemplated (and eventually adopted). Historically, dues increases have resulted in a membership decline; but we just had no way to predict how much.

In this day and age, \$10 probably shouldn't be considered a deal-breaker for someone to choose not to renew. The \$10 dues increase that resulted in Nebraska was probably used as an "excuse" not to renew ---- but, it really shouldn't have been a reason. We need to remember that the price of a membership increased by \$10.00, but the value of that membership is still well worth it. The 2024 members who did not renew need to be reminded of that.

Nebraska was not alone in experiencing a higher-than-normal decrease in renewals. Nationally, just about every department fell short of its expectations,

A second occurrence that impacted our membership was the fact that a Nebraska dues increase could not be decided upon until we met for our convention. The decision was made to defer our first dues notice until October so that all posts could update their individual dues amounts and have them correctly shown on the dues notices mailed out by the national headquarters. Our first notice was delayed to October --- and was delayed a little more because of some problems in Indianapolis.

It was a double-whammy. The dues increase caused some members to choose not to renew. Missing the July notice, we were already chasing the pack when we got into the race. We can look forward to doing much better this year. The first 2026 dues notice from Indianapolis is scheduled for mailing during the first week of July. Let's be ready to process some memberships --- and online renewals are encouraged. The Early Bird drawing will return to September --- where it belongs.

In regard to online renewals, a resolution will be presented at the department convention to mandate that any individual post's dues cannot be less than the sum of current state and national dues. There are a few posts that still subsidize a portion of their members' state and national dues, but so doing prevents members of those posts from being able to renew online. We should make sure that ALL members who choose to do so can renew online, so I wholeheartedly support this change.

Posts that wish to continue subsidizing their members' state and national dues can continue doing so. They just need to give the subsidy directly to the members who pay online instead of paying it to the department when they transmit dues.

I close with a few thoughts about our focus. For the last few years, it seems that the national organization has put emphasis on maintaining a renewal rate of 90% or more. Well, if 90% is success, then success means we declined by 10% --- sort of.

National has tried to establish department goals at about 3% more than the current membership in June or July. However, what they fail to publicize is that the base number they use includes those paid members who died throughout the year after paying their dues. If we need to increase 3% but lost 7% to death like my post did, then we have the need of recruiting 10%.

I don't know the total solution, but we need to start putting more emphasis on recruiting in the coming years. A lot more emphasis.

Crete Post 147 Sponsors "FLAGS FOR CRETE"

Since 2021, Post147 has carried out a community patriotism campaign named "Flags for Crete". This program has answered several needs of both the Post and the community. Among these are the need for the post to generate income to support it's giving to the community, our youth and of course veterans causes. Additionally, it provides the entire community with a sense of patriotism at key times during the year.

The program is structured around a subscription basis whereby both businesses and individual homeowners "subscribe" to this program which places a 3'X5' American flag curbside in front of their property. Many merchants and some homeowners even purchase multiple subscriptions. Currently, flags are placed 5 times per year, covering 7 national

occasions. These include Memorial Day (weekend), Flag Day, July 4th (weekend), Labor Day (weekend, and the flags remain displayed through 9/11) and the 10-day period from Election Day to Veterans Day.

Each subscriber pays for this service on an annual basis. The Post purchases, maintains and places all infrastructure including the flags, poles and a ground sleeve receptacle that is installed permanently on the property. All flags are placed exactly 4 feet from the curb which yields the effect that the streets are lined with the flags when they are out on display.

In 2021, 44 flags went on display for the first time for Veterans Day. Since then, the program has grown to over 260 flags that appear all over town. Lots of feedback tells us that the people of the community love the program and look forward to seeing them each time they are placed. Individuals are now contacting the Post to join the program, so basically, it has become self-perpetuating and continues to grow each time the flags go out.

Funds are used to support our scholarship giving and we have become one of the largest scholarship donors for the high school. We use funds to sponsor multiple Boys and Girls State candidates, the Junior Law Academy and other youth programs. We have also donated to various state and national veterans programs and a major contribution is also granted to our local American Legion Baseball operations.

If your Post is interested in this program for your community, feel free to contact the Commander of Post 147 and we will furnish details on how this works, the record-keeping that is necessary and how the infrastructure is handled. It is a great funds provider, patriotic and loved by the community, but it does entail significant planning and work to carry it out.

PAPILLION COMMUNITY LIVING CENTER

Picture your veteran friend or family member who has been in the hospital for a serious illness, surgery, or declining mental health. They cannot immediately go home by themselves or are waiting for another VA Facility opening (assisted living or intermediate nursing care). Veterans may need respite, skilled rehabilitation/nursing, or palliative/ hospice care.

When this happens in your life, notify your County Service Officer or the VA's Medical Center Social Worker to enroll the patient for the Papillion VA Community Living Center (CLC). (Another Community Living Center is located in Grand Island.) Because a CLC is a "1-B High Complexity" facility, the patient will also need the primary care physician's order for this medical service.

The mission of a CLC is to restore each veteran to his or her highest level of well-being. It is also to prevent declines in health and to provide comfort care. Their stay may be under 2 weeks to over 1 year, if necessary.

American Legion Auxiliary (ALA) volunteers and donors can make a quality impact on this service for veterans. There are friendly, private areas for visiting; and, during warm weather, the outside healing garden. Veterans love BINGO prizes and other treat opportunities, as we all do. ALA can help with their artistic "Recreation Therapies" and other social activities, which are very underfunded by VA cuts. Yet, they still participate in the ALA/VA Veterans Creative Arts Receptions.

The two-year-old Papillion facility is located within CHI Midland and is its first public/private partnership with the Veterans Affairs of the Nebraska-Western Iowa Health Care System. The 5th floor is open, and the 6th floor opens as staffing allows for a total of 34 beds.


