PURPOSE OF THE MEMBER DATA **FORM**

The American Legion Member Data Form (MDF) is a multipurpose form for tracking and providing accurate information on Post members. You can download the form online or on our website. With the exception of transferring members from one post to another, most MDF changes can be made through MyLegion.org.

Note: Members can be transferred online through MyLegion.org if the member is paying their dues at the time of transfer.

The MDF can be used to report deceased members, continuous years, name corrections, address changes, branch of service, war era, and others.

On the MDF, always include the ninedigit member ID number, Post number, and Department name. The signature of the authorized Post officer is required at the bottom of the form. Be sure to mail part 1-3 to Department Headquarters and keep part 4 for your Post files.

Membership transfer from one post to another is handled by completing the MDF. Always ask prospective members if they currently are or have been a member. If the veteran has a current or previous nine-digit ID number, it should be reported on the transfer. If a member signs up as a new member, a duplicate record can be created, and multiple renewal notices will be received by the member.

We are pleased to announce the schedule for the 2023 Junior Law Cadet Program cosponsored by the Nebraska American Legion and the Nebraska State Patrol. This year, we will separate the girl and boy sessions. The sessions will be June 20-21 for boys and June 22-23 for girls at the Nebraska Law Enforcement Training Center, in Grand Island.

We are extremely proud of this program initiated in Nebraska in 1968. The greatest potential for good can be achieved by encouraging all interested and qualified students to submit applications for competitive evaluation, and then later providing opportunities for graduate Cadets to report their experiences to students, Legionnaires, and members of civic and service organizations in your area.

Please study the enclosed information carefully with special reference to the qualifications and timetable for evaluating the applicants. Please have the students fill out the application at our web site www.nebraskalegion.net. This is a fillable form, <u>hand written applications have to be legible</u>.

Then, following an objective evaluation of all applications submitted, and in consultation with, and endorsement by local law enforcement officers at the Post level, endorse the "best male" and "best female" candidate from each school sponsored/represented by your Post. The endorsed applications <u>must be forwarded to Department Headquarters</u> to arrive no later than <u>March 15</u>. Payment is not required before district selection.

Make certain applicants are <u>aware of the driver's license requirement</u> and that they will be required to fire a weapon on the range. Also, note that tobacco use is not authorized. <u>The District</u> <u>Commander is responsible for your District selection session</u> and will notify you of the date and time of this meeting. Your applicant(s) will be notified directly by the District Commander or their designee. Each District will select and rank order their primary and alternate Cadets for each session of the program.

Cost of the training, <u>\$200.00</u> per student, is to be provided by the sponsoring Post (unless your District has another payment plan) to cover the cost of food, T-shirts, classroom materials, and administrative expenses. The Nebraska State Patrol training counselors, facilities, and equipment are provided as a public service.

2023 JUNIOR LAW CADET PROGRAM NEBRASKA DEPARTMENT OF THE AMERICAN LEGION

The law-and-order subcommittee of the Nebraska American Legion has developed the following guidelines for the evaluation and selection of applicants for the Junior Law Cadet program. The 2023 program will be held in 2 separate sessions, boys **June 20-21** and girls **June 22-23** at the Nebraska law enforcement training center at Grand Island.

Basic Requirements:

- (1) A student <u>completing 11th grade</u> and in good health to permit active participation in daily calisthenics and a full schedule of activities.
- (2) A constructive attitude toward "Law and Order" evidenced by a personal history of respectable citizenship and a good driving record.
- (3) Admirable personal appearance to include good grooming.
- (4) An average or better scholastic record and the aptitude and ability to share the knowledge gained through formal and informal reports to fellow students and local civic and service organizations.
- <u>NOTE</u> (5) <u>Possess a valid Nebraska operator's license or learner's permit prior to attending. Not having either</u> the student will not be considered.
 - (6) Cadets <u>will not</u> possess or use alcohol, drugs, or tobacco, in violation of state statutes.
 - (7) Commitment to a law enforcement career **<u>is not</u>** required.
 - (8) Student will reside and attend school in Nebraska.
 - (9) Applicants selected to represent the local American Legion Post will be requested to appear for a District selection interview at a date, time and location to be announced. Interview will probably be scheduled during April.

Timetable for Application:

- JAN 1 Post Commander consults with high school officials, and through local publicity, encourages eligible students to make formal application at the department website http://www.nebraskalegion.net/Programs/Programs/Programs/Programs.html.
- MAR 1 Completed applications with endorsement of the high school superintendent or principal must be submitted to the Post Commander.
- MAR 15 Post Commander must have selected the "best male" and "best female" applicants from among all those submitted from the schools, have added official endorsement signature and have <u>forwarded those</u> <u>applications to Department Headquarters (for each school).</u>
- APR 1 Department Headquarters will have registered all applicants and forwarded the applications and ranking sheets to the appropriate District Commander or designee for the selection interviews. District Commander or designee will notify all applicants by mail or phone of the location, date and time of District selection interview. It is expected that a member of the Nebraska Law Enforcement Officer be involved in the final selection of the district's representatives.
- MAY 1 District Commander must have forwarded to Department Headquarters the <u>two</u> most highly endorsed applicants for <u>2 ea boy's and 2 ea girl's / 3 ea boy and 3 ea girl for Dist 8 and 15</u> and the designated alternates in descending order, after objective review of qualifications and interest as determined by personal interview.
 Payment of <u>\$200 per principal cadet</u> must accompany endorsed applications. In the event that any principal selectee is unable to attend, and there is no designated alternate from that District, Department Headquarters reserves the right to select an alternate.

Participants will be selected by competitive evaluation based on interest, citizenship, evidence of self-discipline, and the ability to share their knowledge with others. Completed applications and an endorsement from your school principal or superintendent must be submitted to your local Post Commander before March 1. Your local Post Commander will select a male and female applicant from each school and forward his selections to Department Headquarters for review. All eligible applicants will be notified by mail of the location, date, and time of their in-person District selection interview. Costs: The sponsoring Post provides for the cost of training.

Activities during the course include but are not limited to: accident investigation, crime and drug investigation, driving a State Patrol car, learn to fire a service weapon (under expert guidance), learn self-defense and assault prevention measures, use of a lie detector, study drug enforcement, proper methods of patrolling, gangs and many issues facing law enforcement today.
